



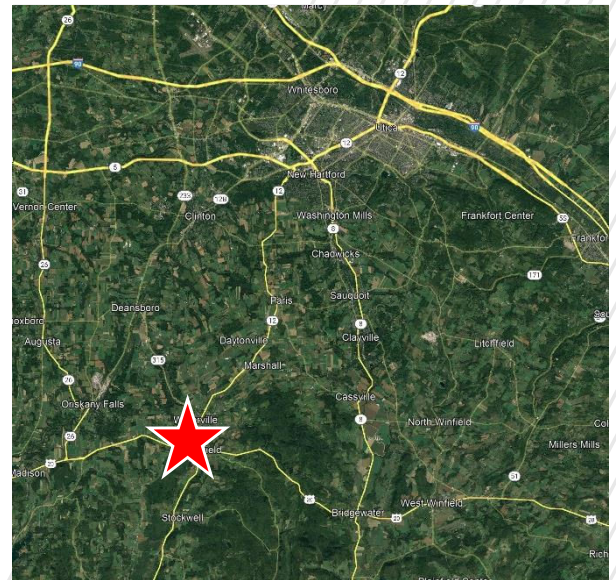
NW Corner of Highway 20 & Highway 12

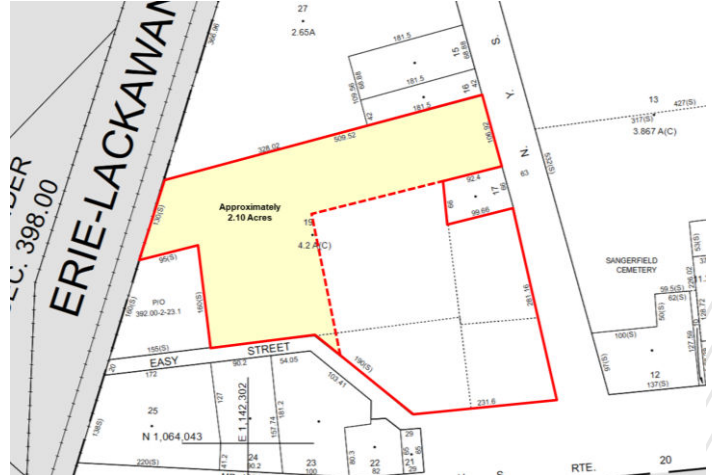

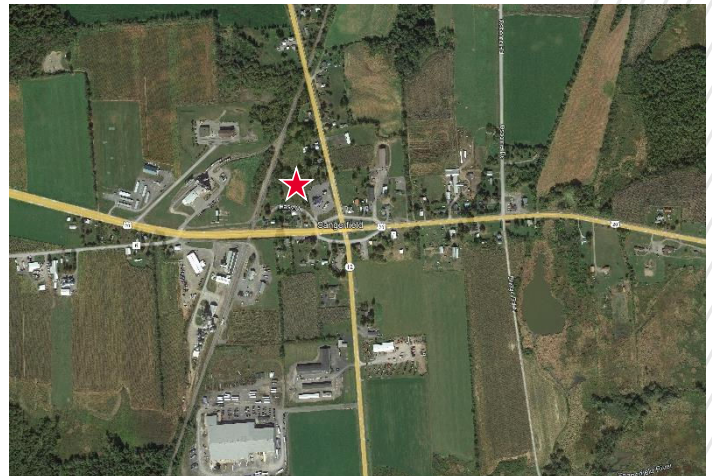
PERTINENT SITE INFO
